1. Call to Order at 12:08 PM: Quorum of Directors present, Lori Wallick was absent.
2. Review and Approval of the July 7, 2020 Board Meeting Minutes, Cheryl Nangeroni moved, Ana Correia-Sanchez seconded, approved by consensus.
3. Reports:
  - 3.1. Randy Ransom, Treasurers Report. Funds on hand \$1,203.83 in the Onpoint Account. Randy shared the general information on new members and dues.
