AED: For use at the courts for cardiac emergency. Cost around \$2k, would need trained individuals to use, can't be left on the courts but locked in Green Box. No decision made.

New Board Members: Eight names were suggest and prioritized by their interest and availability. Three were chosen to ask to join the board: Wayne Bailey, Jackson Darling, and Laura Kenow. Cheryl Nangeroni is contacting Wayne, Austin is contacting Jackson, and Lori is contacting Laura Kenow.

Cheryl Shockey has been asked to consider being the club president. She will decide by our next meeting. We have to have a President officer for our Bylaws and Non-profit status.

Former Secretary, Carina Kistler, was asked if she wanted to stay an active board member, or become an honorary one. She wants be active, and will plan to communicate better when emails and texts are sent to Board members.

Summer Party: September 16th, Saturday is being held at Youngberg Hill Winery for our "End of Season Social Soiree" from 4:00-7:00 pm. A "Save the Date" will go out two months prior, July 16. Plans to have it be a Social occasion, with opportunity for visiting, so there will be no band... background recorded music instead.
